The City of Chillicothe is the recipient of \$268,000 through the Community Development Block Grant (CDBG) program through the Missouri Department of Economic Development for a demolition project This award will provide funding for the demolition of 17 dilapidated residential buildings and 1 commercial building within the city. Green Hills Regional Planning Commission assisted the city by providing grant writing services and will further assist by providing administration services to ensure compliance with federal and state guidelines throughout the project's implementation. This project is a key initiative designed to enhance the city's aesthetic appeal, improve public safety, and promote economic growth by removing abandoned and unsafe structures. This project aligns with the city's ongoing efforts to strengthen its infrastructure and improve the quality of life for its residents.



The City of Green City was awarded \$497,500 in grant funding for street improvements through the Community Development Block Grant (CDBG) program from the Missouri Department of Economic Development. Green City will provide \$50,000 in matching funds for this street improvement project. Green Hills Regional Planning Commission assisted the city by providing grant writing services and will serve as the grant administrator. GHRPC will be responsible for oversight and compliance, both state and federally, of this project.

and inspection services to the enjine and project. This funding will support resurfacing and reconstruction of several key streets in Green City. In addition to improving street surfaces, this project will also improve ditches and drainage systems that have caused persistent flooding issues and deterioration in the past.

Solid Waste Program Grant Awards

The North Missouri Solid Waste Management District Region B provides financial assistance to cities, counties, non-profits, and other organizations that will develop new or improved programs that will reduce the generation of solid waste, will create new markets or improve markets for recovered material, or will improve the handling of items banned from landfills by Missouri law. Current grant awards include:

- The House of Prayer Mission Thrift Store in Chillicothe received grant funding for \$20,000 to purchase a new baler for their operation to divert textiles from the landfill.
- The City of Mercer will be receiving grant funding in the amount of \$1,440 to rotate a recycling trailer in Mercer County.
- Sullivan County will be receiving grant funding in the amount of \$20,000 to purchase cargo containers and to pay for banned and special item disposal. This will serve the patrons of the North Missouri Solid Waste District on the eastern side of the region.



GHRPC's Transportation Planning staff are gearing up to perform sidewalk surveys for communities. Through MoDOT funding GHRPC purchased the equipment that will allow us to map and rate the condition of the sidewalks and pedestrian walkways in a community. The device utilizes GIS location services to build a map of your community's sidewalks to assist with maintenance planning and data to support grant applications. We also have pedestrian counters that we can place in areas that need supporting data to identify pedestrian volume. These applications would be very useful to include in MoDOT Transportation Alternatives Program (TAP) Grants, support Multi-Modal needs of your community, and identify unsafe intersections and assist with ADA improvements.

Reminder: Missouri's Hands-Free Law is Now in Effect!

Stay safe and stay focused! Missouri's new Hands-Free Law prohibits drivers from holding or using their phones while driving, except for hands-free or voice-operated functions. This law is designed to reduce distracted driving and keep everyone on the road safer. Let's all do our part to make Missouri roads safer for everyone!

What you need to know:

- Put your phone down while driving.
- Use Bluetooth, speakerphone, or other hands-free devices if you need to make a call.
- Texting, scrolling, or holding your phone is prohibited while driving.



Promoting Roadway Safety

In partnership with the Missouri Coalition of Roadway Safety Green Hills Regional Planning Commission attended a safety event at the Novinger, Missouri High School during the MSHAA Basketball Tournament on December 3, 2024.

The Coalition of Roadway Safety was there to demonstrate the dangers of driving under the influence by using the "Drunk Goggles", promoting safe driving for teens, and signing people up to participate in Buckle-Up Phone-Down Day.

It is through outreach efforts like this that GHRPC and the Northwest Coalition of Roadway Safety are promoting Show-Me Zero, MoDOT's safety campaign, with the goal of eliminating fatalities in Missouri.
